The first \$4,800 of each contribution from a person will be allocated to the Friends of Barbara Boxer Committee. The first \$2,400 of a person's contribution will be considered designated for the primary election; the second \$2,400 will be considered designated for the general election. The next \$30,400 of each contribution from a person will be allocated to the Democratic National Committee. Any contributor may designate his or her contribution for a particular participant. The allocation formula above may change if any contributor makes a contribution that, when allocated, would exceed the amount that the contributor may lawfully give to any participant.
